

## TERMS & CONDITIONS | WIN a Free Garage Door! from Adams Door Systems (HSE Group of Companies)

Promoter: The HSE Group of Companies Inc.

1. Entry into the Enter to **WIN a Free Garage Door!** (the **Promotion**) is deemed to constitute your acceptance of these Terms and Conditions (the **Agreement**). Entries must comply with this Agreement to be valid.
2. **Who can enter?** Entry is only open to residents of Ontario who are at least nineteen (19) years of age. The Promoter's directors, management, employees, agencies and suppliers associated with this Promotion, along with all of their respective family members who reside with them, are not eligible to enter.
3. **Promotion Period:** This Promotion commences at 12:01 am ET on Monday July 25<sup>th</sup>, 2016 and ends at 11:59 pm ET on August 8<sup>th</sup>, 2016.
4. **How to enter?** To enter the Promotion, during the Promotion Period, fill out the entry form at [www.adamsdoorsystems.com](http://www.adamsdoorsystems.com) (an **Entry**).
5. **Receipt of Entries:** All Entries will be confirmed by the Promoter via an instant message after the Entry and associated contact details have been received.
6. **How many times can you enter? Limit:** One (1) Entry per person during the entire Promotion Period. Any further attempted Entries will be declared void.
7. **The draw** All valid Entries received during the Promotion Period will be collected and included in a random draw. The draw will take place on a business day ("**Business Day**" is any day on which the Promoter is open for business) during business hours at the Promoter's head office, 251 Consumers Rd., Suite 403, Toronto ON M2J 1R3 on August 4<sup>th</sup>, 2016 or as soon thereafter as practical.
8. **The Prize:**

There is one (1) Prize available to be won, an insulated, energy-efficient, single car garage door, having an approximate retail value of \$1000.00 installed. Dimensions of the Prize is 8ft wide x 7 ft high. Manufacturer of the door is Cloplay. Premium series garage single garage door. Winner may select colour from among the specified color options.

Includes services: the removal and disposal of an existing garage door and the installation of the new garage door.

Does not include windows or door opener. These can be added and an upgrade to a double garage door can be arranged at an additional cost to be determined at the time of inspection.
9. **Odds of winning.** The odds of winning a Prize depend upon the number of eligible Entries received during the Promotion Period.
10. **Notification, Skill Testing Question and Release:** The potential winner will be notified in person, by telephone and/or email during business hours on the day of the monthly

draw, or within five (5) Business Days from the date of the draw. The potential winner must correctly answer a skill-testing question and sign and submit a Release before being declared to be the Winner. The Release will: (a) confirm the potential winner's eligibility to enter the Promotion and compliance with this Agreement. Where requested by the Promoter, a potential winner must provide evidence that this is the case and, in particular, provide evidence to verify the potential winner's Personal Information (see Privacy); (b) confirm that the name and photograph or other likeness of the Winner may be used for promotional purposes by the Promoter, unless the Winner notifies the Promoter at the time of accepting the prize that he or she does not consent to such use; (c) confirm that the potential winner agrees to participate in any media activities surrounding the Promotion; (d) confirm that, if confirmed as a Winner, his/her name may be published on the Promoter's website and any of its social media accounts, without compensation to the Winner, for promotional purposes; and (e) release the Promoter, its suppliers, agents and administrators and their respective employees and agents from any and all liability from any loss, harm, damage, cost or expense arising out of participation in this Promotion, or the acceptance, use or misuse of any Prize. If the Release is not completed and returned to the Promoter by the specified deadline, the potential winner will be deemed to be ineligible and another random draw (as described above) will be held with respect to that particular Prize.

11. **Re-Draws.** If the Promoter is unable to contact the potential winner at the contact information provided in the Entry after three (3) attempted contacts, that Entrant will be deemed to be ineligible and another random draw (as described above) will be held with respect to that particular Prize.
12. **Disqualification:** The Promoter reserves the right to verify and confirm any Entry and to disqualify any Entrant who the Promoter determines (in its sole discretion) to have forged, manipulated or tampered with an Entry or the Promotion, who submitted an Entry with incomplete information or that does not comply with this Agreement, or who does not correctly answer the skill-testing question, or does not complete and provide a signed copy of the Release within the required time-frame, or does not provide other information as requested.
13. **Prize delivery:** The Prize includes the installation of the Prize described above, and arrangements will be agreed to by an agent of the Promoter and the Winner for this to be done at a convenient time on a Business Day. The Promoter will contact the Winner within five (5) Business Days of receiving the completed and signed Release from the Winner to discuss those arrangements.
14. **Prizes not transferrable or exchangeable:** Prizes are not transferable or exchangeable (except at the discretion of the Promoter) and may not be redeemed for cash. All Prizes are accepted entirely at the risk of the Winner, and the Promoter excludes all warranties in connection with any Prize to the extent permitted by law (regular product and service warranties may apply to products or services provided to the Winner by the Promoter). The Promoter reserves the right to substitute any Prize with a prize of equal or greater value (including where a Prize is unavailable). No compensation will be payable to the Winner if s/he is unable to use the Prize as stated.

repetitive, robotic, programmed or similar entry methods or agents, including the use of a competition entry service (as determined in the absolute discretion of the Promoter) will be deemed to be void.

16. **Variation or cancellation of the Promotion:** The Promoter reserves the right, in its sole discretion, to modify the terms of this Agreement and the Promotion, to change the dates of any random draw, or to substitute any of the Prizes, for any reason, without further notice.
